Safeguarding the health, safety, and welfare of the public is the ultimate goal of the Board of Professional Licensing (BPL) and the Health Care Professions Licensing Board (HCPLB). BPL and HCPLB are two independent regulatory government agencies operating under one office and administered by an Executive Director with two Office staff. Both Boards are state government agencies that license and regulates different professions under each Board’s jurisdiction.

BPL and HCPLB derives its funding through four sources: 1) Local Appropriation, 2) Federal (ARPA), 3) BPL License Fees and 4) HCPLB License Fees. Local appropriation and federal funding under ARPA pay for the three-office staff and BPL and HCPLB Revolving Funds pay for the office general operations.

Since 2020 and despite COVID-19 Pandemic, BPL Board made significant growth in 2022 in the number of active registered licenses by 28%. Out of the total number of active licenses, only 14% are CNMI residents and 86% are residing outside of the CNMI. Since 2020, HCPLB grew by 14% active registered licenses with 44% residing in CNMI and 56% residing outside of CNMI. Despite a small number of complaints reported, no license was revoked and both BPL and HCPLB continue to strengthen its ability to protect our CNMI consumers.

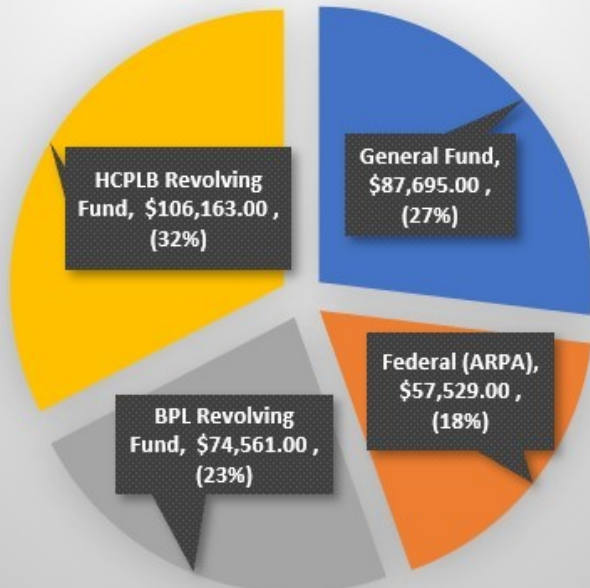

WHAT'S NEXT...

RISE ABOVE THE PANDEMIC CHALLENGES TO ENSURE THE SAFETY OF THE PUBLIC

During FY 2021-2022, The Board focused on the promulgation of several counseling professions and focused on internal improvements that streamline and improve its critical licensing process. Although BPL and HCPLB have done so much to improve the licensure process, there is still much to be done.

CNMI Government recently launched Energov, a new integrated and automated software program that will give access to multi agencies within the CNMI Government to share data and workflow in the permitting and licensing processes. Although there are still some challenges in getting Energov fully operational, the benefits are great and full implementation is in the works to kickoff in December of 2022. Office staff will begin training throughout the month of November and the following services will become available:

- Allow potential applicants to apply and follow-up status of their applications online;
- Applicants to be able to pay online;
- Provide a user-friendly service for license verification;
- And gradually move into e-licensing

Of greatest challenge to BPL and HCPLB is the need to provide more on-site inspection for compliance and investigate complaints as they come in. The position for an investigator is currently vacant and would have to be filled immediately to enforce the regulations that restrict professional practice to individuals that are licensed in the CNMI.
