The 3rd Senatorial District Municipal Governance

<u>Separate & Distinct Entity</u>

Article VI, § 1 Creation

The *mission* of the 3rd senatorial district local governance remains committed to adhering to Article VI of the CNMI Constitution which provides for local municipal governance in the Commonwealth. The 17th Saipan and Northern Islands Municipal Council ("the Council"), as are other municipal councils in the CNMI, is established by the Constitution in § 1 to serve and take action as a separate and distinct agency of municipal governance for purposes of and in exercise, performance and conduct of its mission-driven administration and operation as a municipal entity distinct and separate from the central executive government and administration.

Article VI, § 6 Authority

The council's *specific* Constitutional authority for the conduct of its administration and operation is expressly granted in § 6 to adopt its own governing administration and operational Rules of Procedures ("the Council Rules") which the current council adopted in January 2023.

Article VI, § 7 Authority

The Constitution in § 7 also grants explicit *general* powers of the municipal councils to *all* local matters of a predominately local nature not pre-empted by the Commonwealth Legislature, in exercise and performance of the council's Constitutional authority established in § 1 as a distinct and separate municipality governance for and in exercise, performance and conduct of the local council's administration and operation as a municipal entity by and through its own Rules of Procedures.

Article II, § 6 Authority

The Constitution also provides general authority for local (municipal) ordinances to be adopted by agencies of local government established under article VI, § 6(b) in 1978 ,and as amended in § 8 in 1985.

Prescribed Constitutional Authorities

- *Provide assistance to the mayor on annual budget formulation delineating local (municipal) needs;
- *Approve reprogramming of funds by Executive Branch department in the approved budget upon request by an Executive Branch department head in consultation with the mayor;
- *Confirm resident department heads stationed on their island or islands;
- *Council presiding officer automatically become acting mayor when a mayor cannot discharge the duties of office of mayor for reason of physical or mental disability; and
- *Authorities, duties and powers authorized by law whenever the mayor is absent from 3rd senatorial district of Saipan or the N.Islands.

Executive Council of Mayors & Councils: Article VI, § 5

The Constitution in Article VI, § 5 provides mandatory membership of and participation by Chairpersons of Municipal Councils in a Governor's Council. Among the mandatory duties of mayors and presiding council officers shall be to provide advise to the governor on government operations and local matters. The governor's executive council is to be presided by the governor. This local group shall meet regularly or at least four times each year: the executive group is required to consider matters concerning the relationship between the Commonwealth and its separate principal islands. Among the overriding mission of the current third senatorial council is the formation of a charter municipality, like the charter municipalities of the first and second senatorial districts with accompanying visions of decentralized municipal treasury, finance, personnel and procurement that provide a more efficient, timely, reliable, and effective service to the municipalities which serve as strategic targets or goals based on the operational and administrative requirements of the demographics of the local municipalities and responsive to the exigencies unique to the respective municipal governance throughout the CNMI for the improvement of the overall quality of life locally that is beneficial to the Commonwealth as a whole.



Charting the Future by Mindfully Navigating Our Past

The sixteenth (16th) year commemorative anniversary of the Chalan Kanoa Leadership Memorial Kiosku highlights the core prominence of home grown leadership in the territories of the United States and the pre-eminence of self-governance charted by local leaders in political relationship with the United States of America following the end of World War II in June 1944, when the United States took responsibility as the administering authority under the United Nations Trusteeship Council for the social, economic, education, and political development of the Northern Mariana Islands, when the islands were transitioned from post-war Naval administration to civilian Trust Territory of the Pacific Islands (TTPI) administration headquartered in Capital Hill, Saipan.

Prior to the dissolution of the TTPI, the Northern Marianas exercised its sovereign right of self-determination and the people voted to establish closer political relationship with the United States formalized in a Covenant Agreement entered into by the Northern Marianas and the United States of America in 1975. In 1976, the first Constitutional Convention delegates drafted the first Constitution of the Commonwealth of the Northern Mariana Islands, which became effective in 1978, and amended in 1985, to be attuned with the socio-economic realities of the newly established local Constitutional government seven years later by the second constitutional convention delegates.

As the first published souvenir portrait 80 years following WWII by the third senatorial district council, this publication is appropriately dedicated to three (3) longest serving members in the municipality governance—namely, the current council vice chairwoman Tonie Manibusan Tudela of the current 17th council, who has served for twenty (20) years this year followed by the late David Lian Igitol, who served the council for ten (10) years; and the current council chairwoman Marian Deleon Guererro Tudela, who is presently serving her eighth (8) year in the Third Senatorial District municipal council.

Current vice chairwoman Tonie M. Tudela became the first woman President of the Association of Mayors, Vice Mayors and Municipal Council Members (AMIM) of Guam and the CNMI from the CNMI in 2007. In 2008, the AMIM president was also the chairwoman of the municipal council which organized and founded the Chalan Kanoa Leadership Memorial Kiosku in 2008 along with vice chairman/secretary Ramon Blas Camacho (who is the current Saipan mayor) and Councilman Felipe Quitugua Atalig (a former member of the Congress of Micronesia and a delegate to the 1st CNMI Constitutional Convention).

For her part, Council chairwoman Marian Deleon Guerrero Tudela became the first woman mayor for the Commonwealth of the Northern Mariana Islands for Saipan following the untimely passing of Saipan Mayor Donald Flores in 2014.

The late David L. Igitol became a pioneer council as the first vice chairman of the first Saipan and Northern Islands Municipal Council in 1990. Vice chairman Igitol joined first council chairman, the late Eloy S. Inos (also former CNMI Lt. Governor in 2009-2013 and Governor in 2013-2015) and First council secretary Francisco DLG. Crisostimo in the three-member body as elected members of the council which ended in 1992.

First council vice chairman Igitol, however, continued his public service in the third senatorial district municipal council as chairman in the second council (1992-1994); the third council (1994-1996); the fourth council (1996-1998); and the fifth municipal council (1998-2000) for eight (8) consecutive years, or for a total of ten (10) years, half the term of the longest serving council Tonie Manibusan Tudela, who is presently serving her 20th year of public service in the local municipal council for the 3rd Senatorial District of Saipan and Northern Islands, together with current chairwoman Marian Deleon Guerrero Tudela, who herself became the first woman mayor of Saipan and the Commonwealth of the Northern Mariana Islands, presently serving her eighth year with current council vice chairwoman Tonie Manibusan Tudela serving her twentieth year of public service in the municipal council that was once a chartered municipality during the Naval Administration and the Trust Territory administration.

Ironically, the chartered form of municipal governance was terminated by the first Constitutional delegates for a more top down central governance. Amendment 25 in 1985, however, adjusted the command-n-control style of governance for a more decentralized home rule via chartered municipality in the first and second senatorial districts of Rota and Tinian. Saipan, however, opted for a home rule governance via precinct commissioners but later scrapped by a 1987 legislative initiative ("the initiative") in favour keeping the office of Saipan mayor without the precinct commissioners replaced by a three-member municipal council equal to Rota and Tinian's substantially smaller populations.

Although the legislative initiative failed to establish the third senatorial district as a chartered municipality, like Tinian and Rota, Saipan Mayor Juan Borja Tudela approved two pivotal municipal ordinances to establish a charter commission to draw up a municipal charter for presentation to the electorates in the third senatorial district of Saipan and Northern Islands, in addition to allowing for Saipan municipal treasury within the Saipan mayor's office back since 2000. As of 2024, neither of these municipal ordinances has been implemented on Saipan.
